



## State aid: Commission approves €1.2 billion Greek scheme providing grants for SMEs to support economy in coronavirus outbreak

Brussels, 8 April 2020

The European Commission has approved a  $\leq 1.2$  billion Greek aid scheme to support the Greek economy in the context of the coronavirus outbreak. The scheme was approved under the State aid <u>Temporary Framework</u> adopted by the Commission on 19 March 2020, as <u>amended on 3 April 2020</u>.

Executive Vice-President Margrethe **Vestager**, in charge of competition policy, said: "*Small and medium-sized enterprises are the backbone of our economy, and they have been particularly hard hit by the coronavirus outbreak. This*  $\in$  1.2 *billion Greek scheme will enable direct grants to ensure SMEs can continue their activities in these difficult times and help them* bounce back afterwards. We will continue to work in close cooperation with Member States provide solutions to tackle the economic effects of the outbreak in line with EU rules."

## The Greek support measures

Following the approval of a  $\leq 2$  billion Greek guarantee measure on 3 April 2020 and a second scheme providing  $\leq 1$  billion in repayable advances to support companies affected by the coronavirus outbreak on 7 April 2020, Greece notified to the Commission under the Temporary Framework a scheme to support small and medium-sized enterprises (SMEs) affected by the coronavirus outbreak. The support takes the form of grants and the scheme has an estimated budget of  $\leq 1.2$  billion.

The scheme is intended to cover interest up to  $\in$ 800 000 per companyon existing debt obligations (fixed-maturity loans, bonds or bank overdrafts) for a period of 3 months, with an option for extension for another 2 months.

The scheme will apply to the whole territory of Greece and will be open to SMEs from sectors affected by the coronavirus outbreak. The scheme is designed to support the liquidity of SMEs facing temporary difficulties as a result of the outbreak and, thus, remedy a serious disturbance in the Greek economy.

The Commission found that the Greek measure is in line with the conditions set out in the Temporary Framework. In particular: (i) the aid amounts do not exceed the threshold foreseen by the Temporary Framework, (ii) the grants are granted only to solvent enterprises, (iii) the scheme is of temporary nature, and (iv) is proportionate to remedy the consequences of the serious disturbance caused by the coronavirus outbreak.

The Commission concluded that the measure is necessary, appropriate and proportionate to remedy a serious disturbance in the economy of a Member State, in line with Article 107(3)(b) TFEU and the conditions set out in the Temporary Framework.

On this basis, the Commission approved the measure under EU State aid rules.

## Background

The Commission has adopted a Temporary Framework to enable Member States to use the full flexibility foreseen under State aid rules to support the economy in the context of the coronavirus outbreak. The Temporary Framework, as <u>amended on 3 April 2020</u>, provides for the following types of aid, which can be granted by Member States:

**Direct grants, equity injections, selective tax advantages and advance payments** of up to  $\in 100,000$  to a company active in the primary agricultural sector,  $\in 120,000$  to a company active in the fishery and aquaculture sector and  $\in 800,000$  to a company active in all other sectors to address its urgent liquidity needs. Member States can also give, up to the nominal value of  $\in 800,000$  per company zero-interest loans or guarantees on loans covering 100% of the risk, except in the primary agriculture sector and in the fishery and aquaculture sector, where the limits of  $\in 100,000$  and  $\in 120,000$  per company respectively, apply.

(i) **State guarantees for loans taken by companies** to ensure banks keep providing loans to the customers who need them. These state guarantees can cover up to 90% of risk on loans to help businesses cover immediate working capital and investment needs.

(ii) **Subsidised public loans to companies** with favourable interest rates to companies. These

loans can help businesses cover immediate working capital and investment needs.

(iii) **Safeguards for banks that channel State aid to the real economy** that such aid is considered as direct aid to the banks' customers, not to the banks themselves, and gives guidance on how to ensure minimal distortion of competition between banks.

(iv) **Public short-term export credit insurance** for all countries, without the need for the Member State in question to demonstrate that the respective country is temporarily "non-marketable".

(v) **Support for coronavirus related research and development (R&D)** to address the current health crisis in the form of direct grants, repayable advances or tax advantages. A bonus may be granted for cross-border cooperation projects between Member States.

(vi) **Support for the construction and upscaling of testing facilities** to develop and test products (including vaccines, ventilators and protective clothing) useful to tackle the coronavirus outbreak, up to first industrial deployment: This can take the form of direct grants, tax advantages, repayable advances and no-loss guarantees. Companies may benefit from a bonus when their investment is supported by more than one Member State and when the investment is concluded within two months after the granting of the aid.

(vii) **Support for the production of products relevant to tackle the coronavirus outbreak** in the form of direct grants, tax advantages, repayable advances and no-loss guarantees. Companies may benefit from a bonus when their investment is supported by more than one Member State and when the investment is concluded within two months after the granting of the aid.

(viii) **Targeted support in the form of deferral of tax payments and/or suspensions of social security contributions** for those sectors, regions or for types of companies that are hit the hardest by the outbreak.

(ix) **Targeted support in the form of wage subsidies for employees** for those companies in sectors or regions that have suffered most from the coronavirus outbreak, and would otherwise have had to lay off personnel.

The Temporary Framework enables Member States to combine all support measures with each other, except for loans and guarantees for the same loan and exceeding the thresholds foreseen by the Temporary Framework. It also enables Member States to combine all support measures granted under the Temporary Framework with existing possibilities to grant de minimis to a company of up to  $\leq$  25,000 over three fiscal years for companies active in the primary agricultural sector,  $\leq$  30,000 over three fiscal years for companies active in the fishery and aquaculture sector and  $\leq$  200,000 over three fiscal years for companies active in all other sectors over three fiscal years. At the same time, Member States have to commit to avoid undue cumulation of support measures for the same companies to limit support to meet their actual needs.

Furthermore, the Temporary Framework complements the many other possibilities already available to Member States to mitigate the socio-economic impact of the coronavirus outbreak, in line with EU State aid rules. On 13 March 2020, the Commission adopted a <u>Communication on a Coordinated</u> <u>economic response to the COVID-19 outbreak</u> setting out these possibilities. For example, Member States can make generally applicable changes in favour of businesses (e.g. deferring taxes, or subsidising short-time work across all sectors), which fall outside State Aid rules. They can also grant compensation to companies for damage suffered due to and directly caused by the coronavirus outbreak.

The Temporary Framework will be in place until the end of December 2020. With a view to ensuring legal certainty, the Commission will assess before that date if it needs to be extended.
